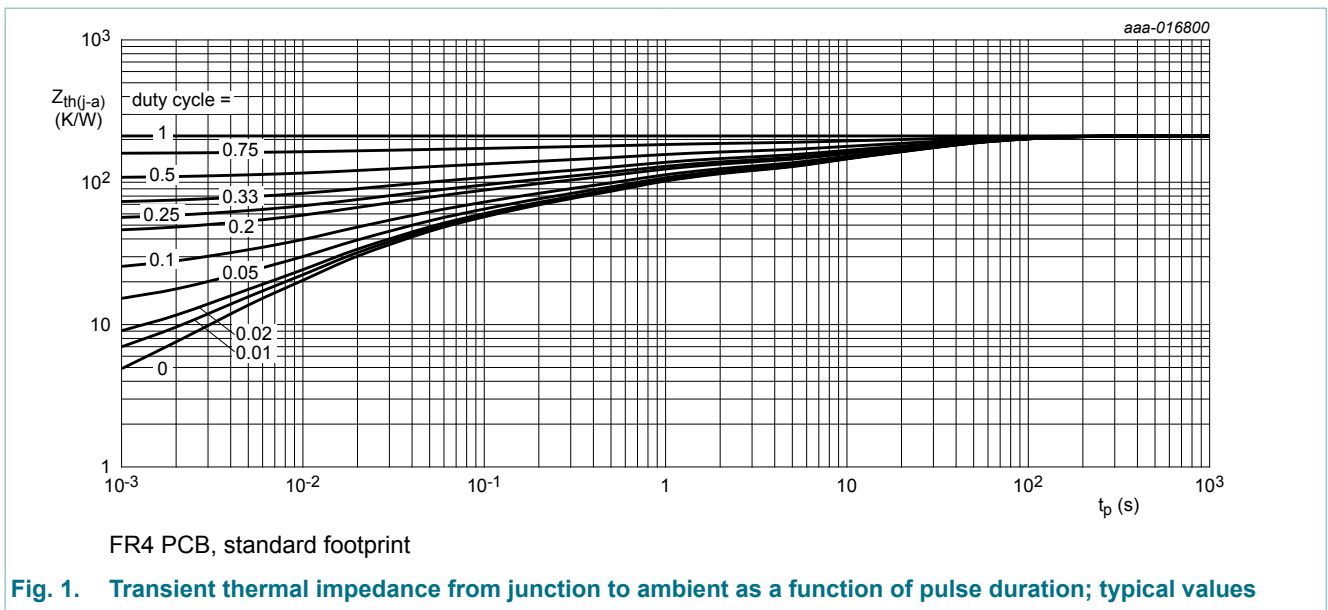

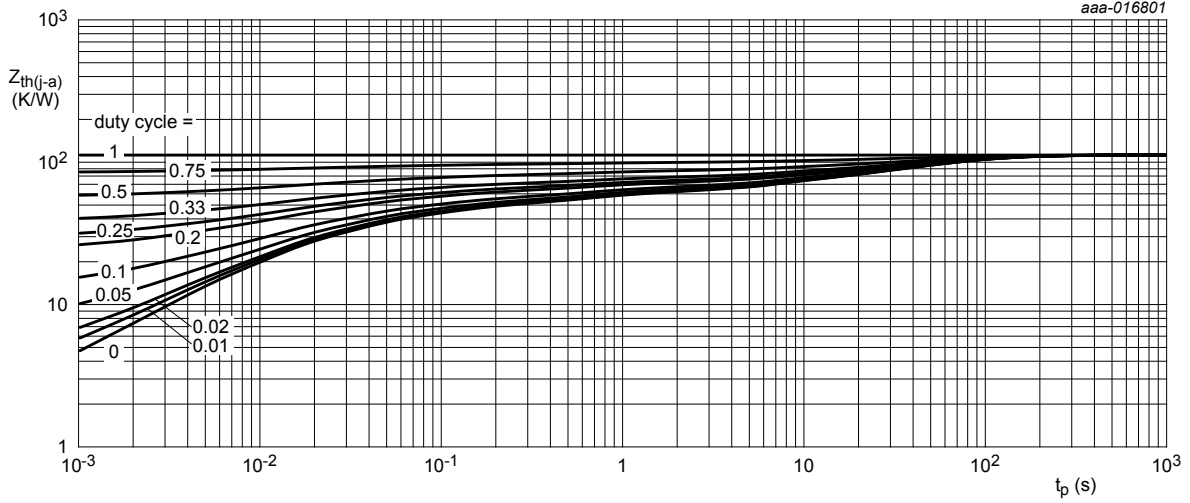

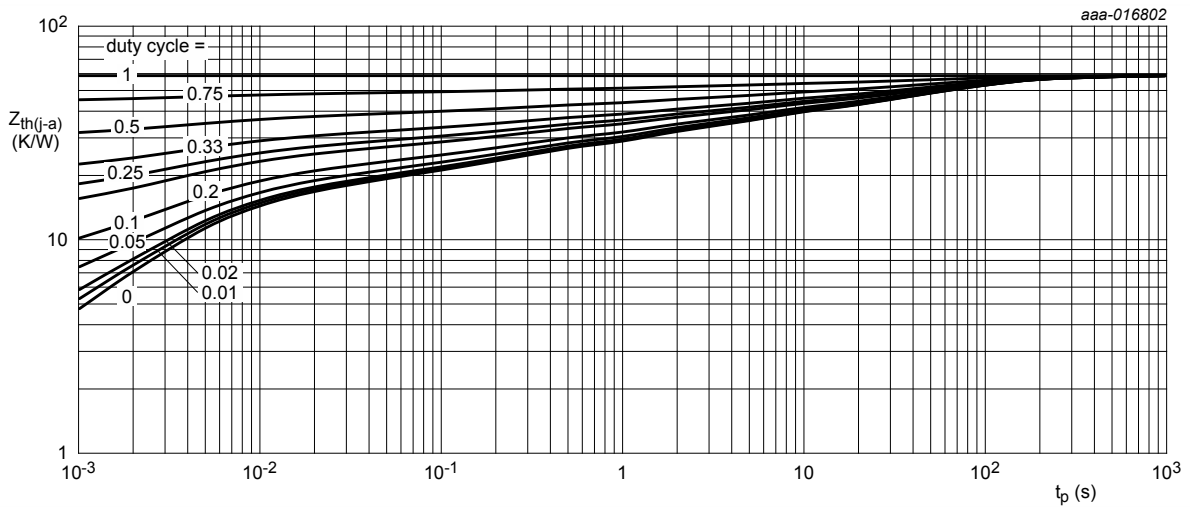

Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values



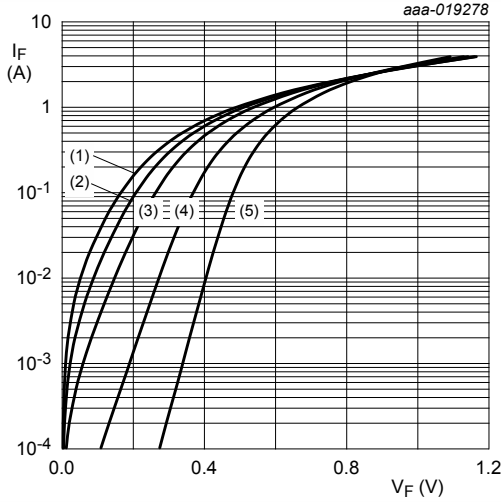
Ceramic PCB, Al<sub>2</sub>O<sub>3</sub>, standard footprint

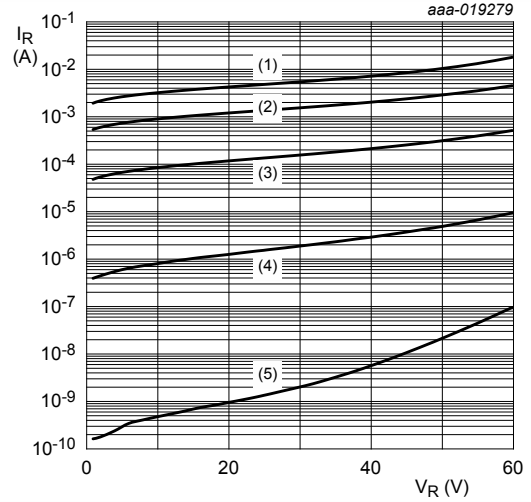

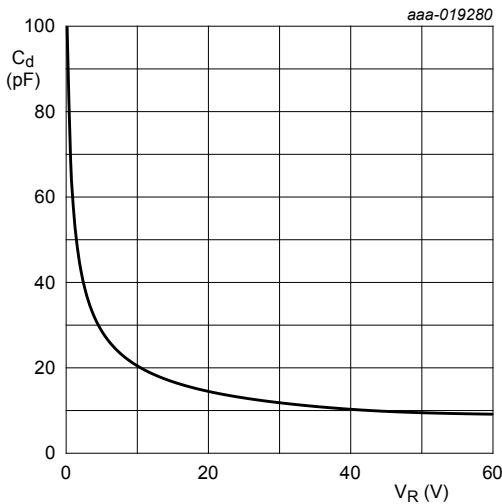

**Fig. 4. Forward current as a function of forward voltage; typical values**



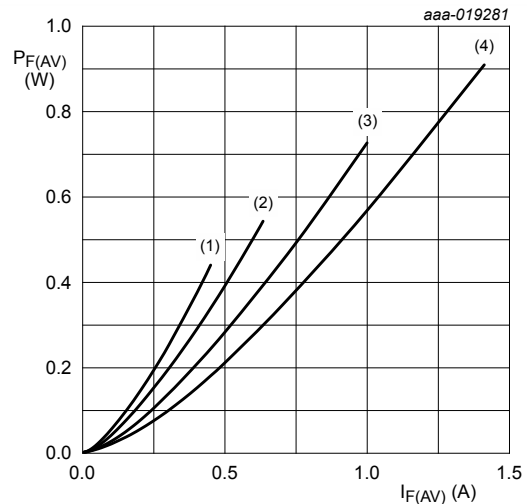

**Fig. 5. Reverse current as a function of reverse voltage; typical values**



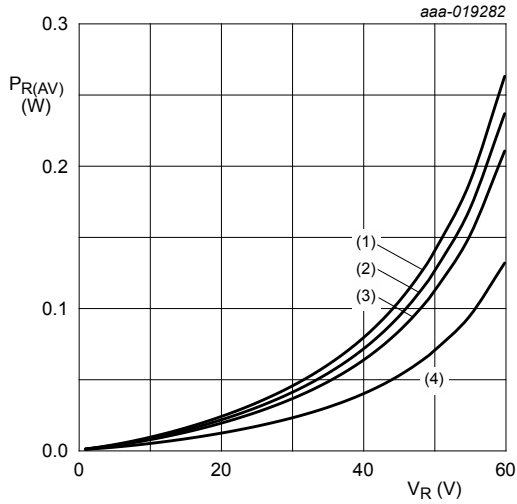

**Fig. 6. Diode capacitance as a function of reverse voltage; typical values**



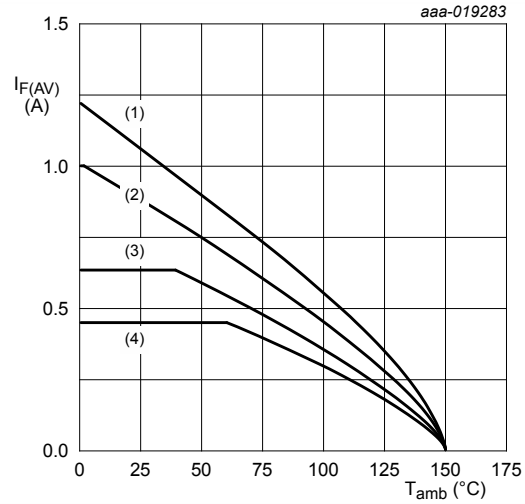

**Fig. 7. Average forward power dissipation as a function of average forward current; typical values**



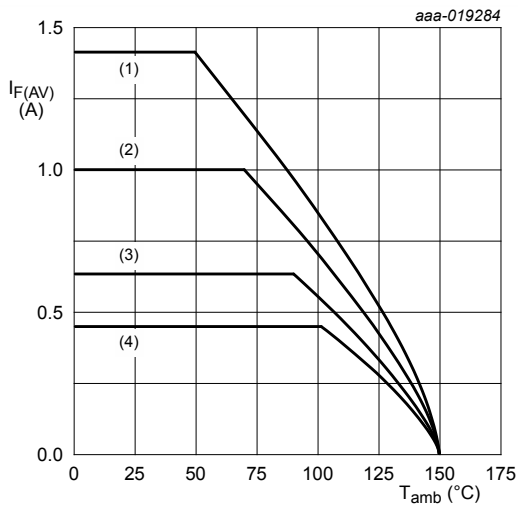

**Fig. 8.** Average reverse power dissipation as a function of reverse voltage; typical values



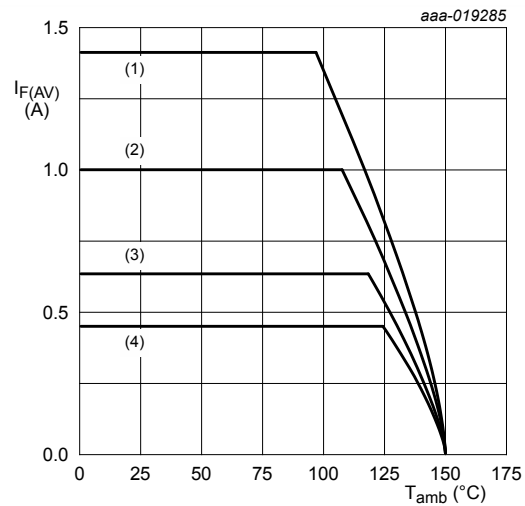

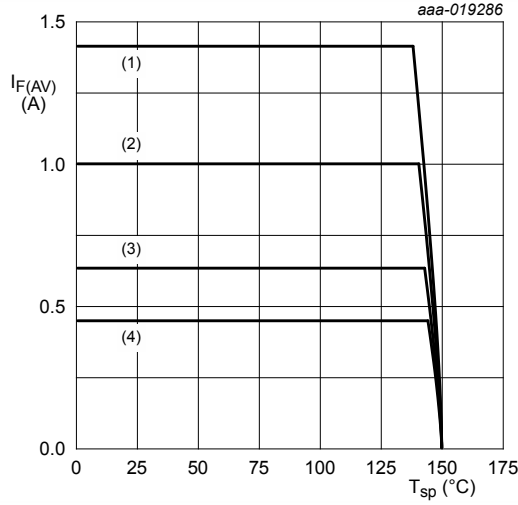
**Fig. 10.** Average forward current as a function of ambient temperature; typical values

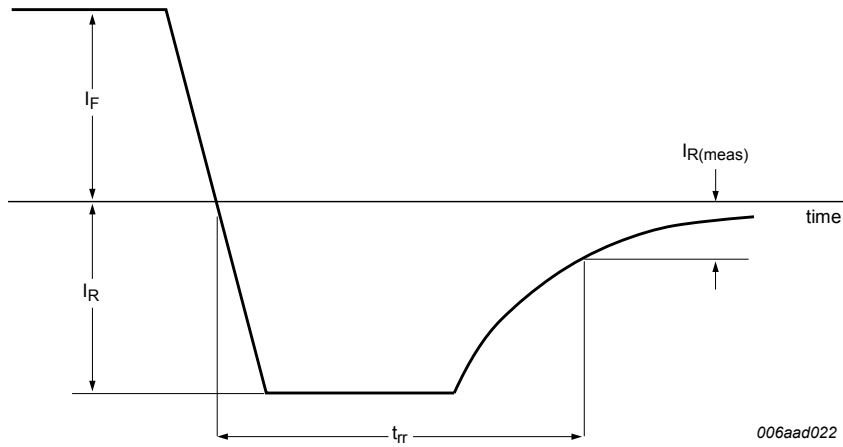


Fig. 13. Reverse recovery definition; step recovery

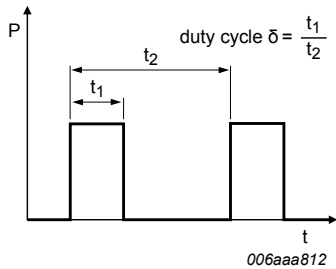


Fig. 14. Duty cycle definition

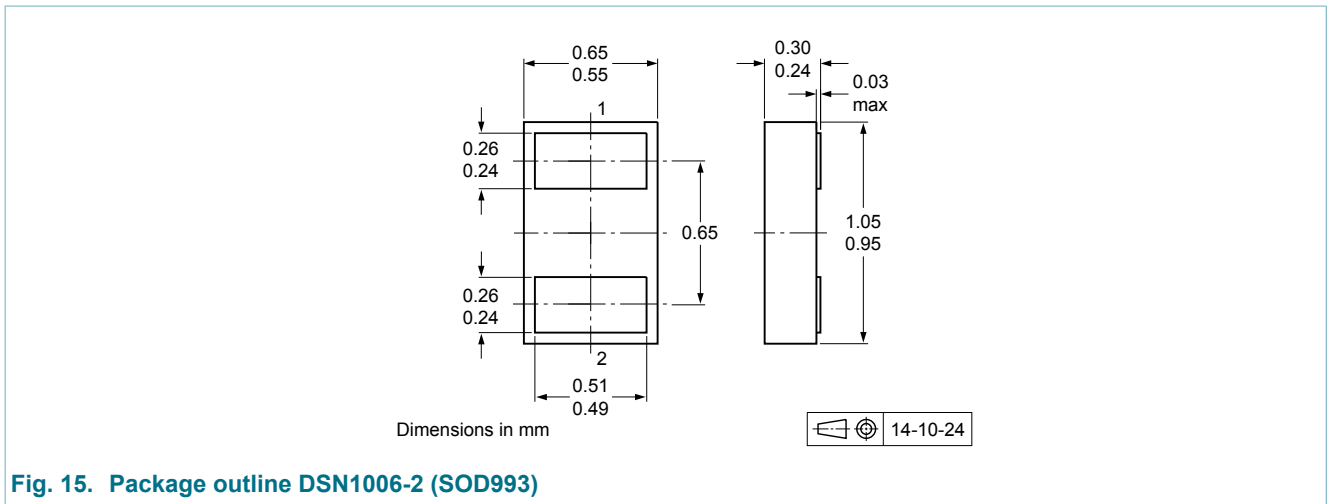


Fig. 15. Package outline DSN1006-2 (SOD993)

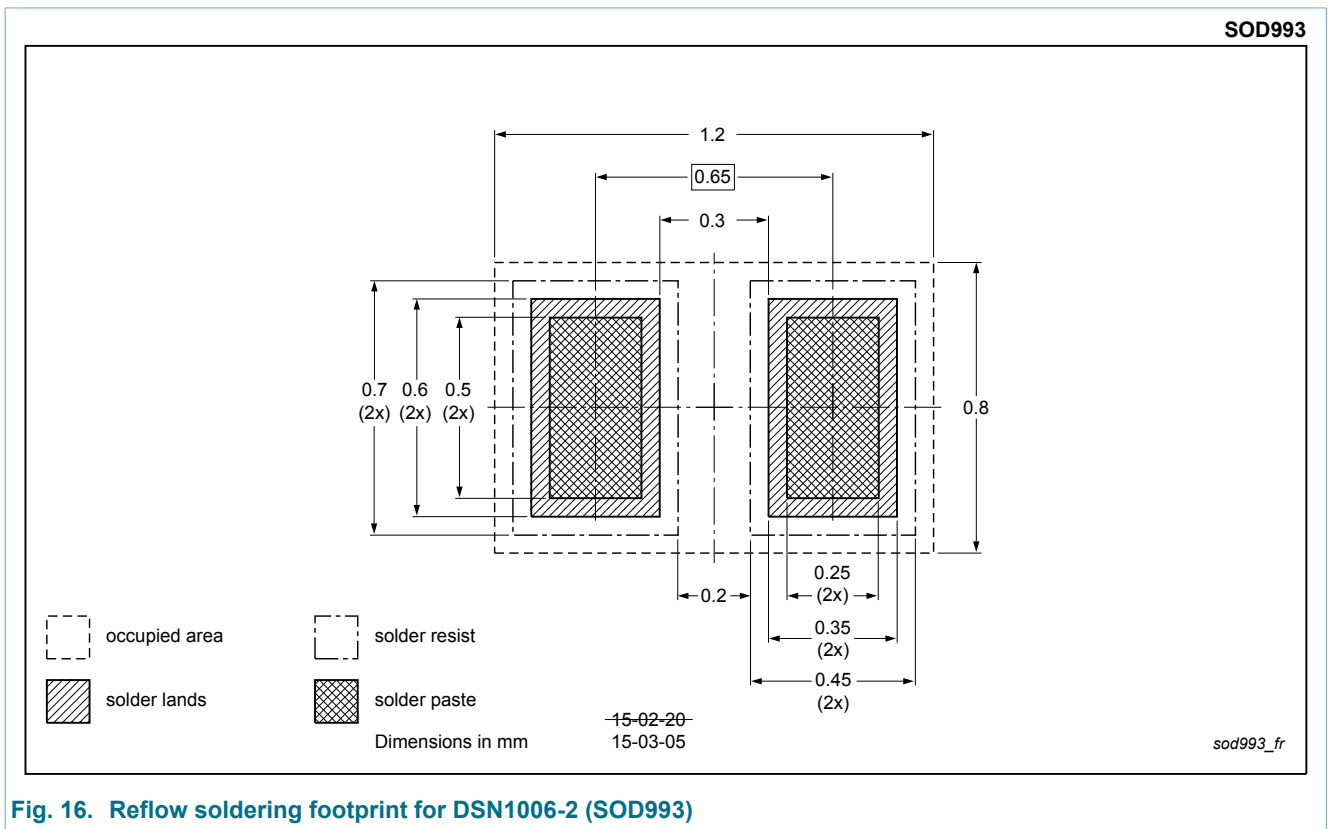


Fig. 16. Reflow soldering footprint for DSN1006-2 (SOD993)

Due to the special product design, Nexperia investigated the board assembly process parameters. In order to have an optimum soldering quality, Nexperia advises to follow the assembly recommendations explained in AN11689.
