NextPowerS3 is particularly suited to high efficiency applications at high switching frequencies.







Fig. 4. Transient thermal impedance from junction to mounting base as a function of pulse duration






Fig. 6. PCB layout for thermal resistance junction to ambient minimum footprint; FR4 Board; 2oz copper







Fig. 8. Drain-source on-state resistance as a function of gate-source voltage; typical values




