


Fig. 1. Normalized total power dissipation as a function of mounting base temperature




Fig. 2. Continuous drain current as a function of mounting base temperature.




Fig. 3. Safe operating area; continuous and peak drain currents as a function of drain-source voltage




Fig. 4. Transient thermal impedance from junction to mounting base as a function of pulse duration; typical values




Fig. 5. Forward transconductance as a function of drain current; typical values

$$T_j = 25 \,^{\circ}C; V_{DS} = 15 V$$




Fig. 6. Input and reverse transfer capacitances as a function of gate-source voltage; typical values

$$V_{DS} = 0V; f = 1MHz$$




Fig. 7. Drain-source on-state resistance as a function of gate-source voltage; typical values

$$T_j = 25 \,^{\circ}C; I_D = 25 \,^{\circ}A$$




Fig. 9. Output characteristics: drain current as a function of drain-source voltage; typical values

$$T_j = 25 \,^{\circ}C$$




Fig. 8. Transfer characteristics: drain current as a function of gate-source voltage; typical values

$$V_{DS} > I_D \times R_{DSon}$$




Fig. 10. Sub-threshold drain current as a function of gate-source voltage

$$T_j=25\,^{\circ}C; V_{DS}=5\,V$$





Fig. 11. Gate-source threshold voltage as a function of junction temperature






Fig. 13. Normalized drain-source on-state resistance factor as a function of junction temperature

$$a = \frac{R_{DSon}}{R_{DSon(25^{\circ}C)}}$$




Fig. 12. Drain-source on-state resistance as a function of drain current; typical values

$$T_j = 25 \,^{\circ}C$$




Fig. 14. Gate charge waveform definitions




Fig. 15. Gate-source voltage as a function of gate charge; typical values

 °C; $I_D = 75$ A




Fig. 16. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values

$$V_{GS} = 0V; f = 1MHz$$





Fig. 17. Source current as a function of source-drain voltage; typical values
