









Component Location on Pad



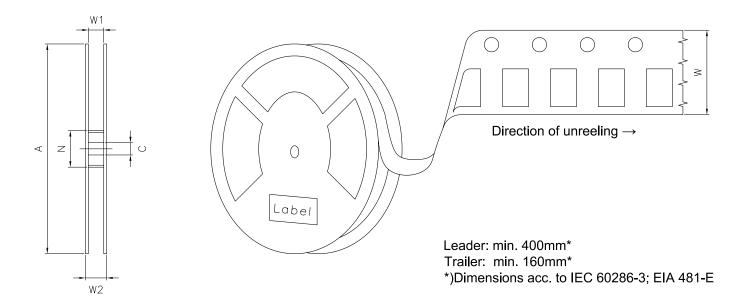

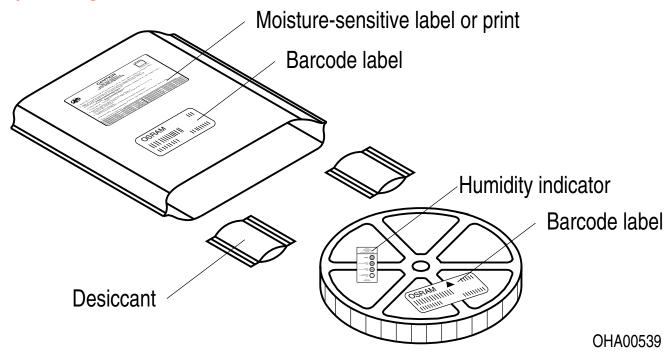
