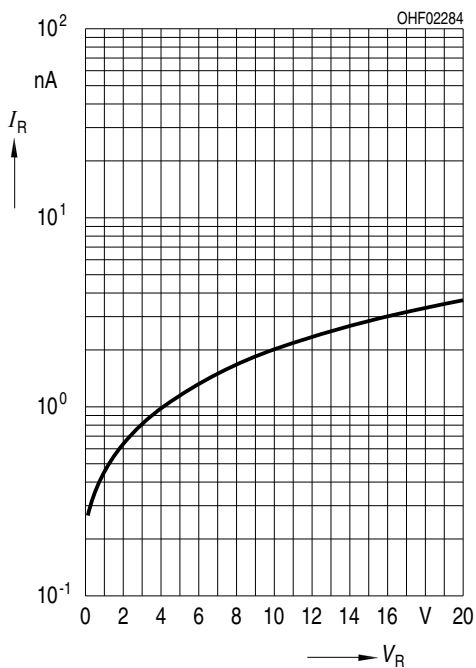

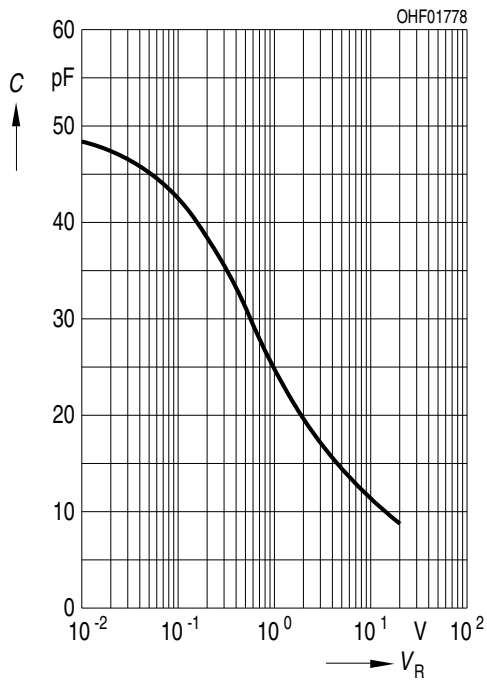

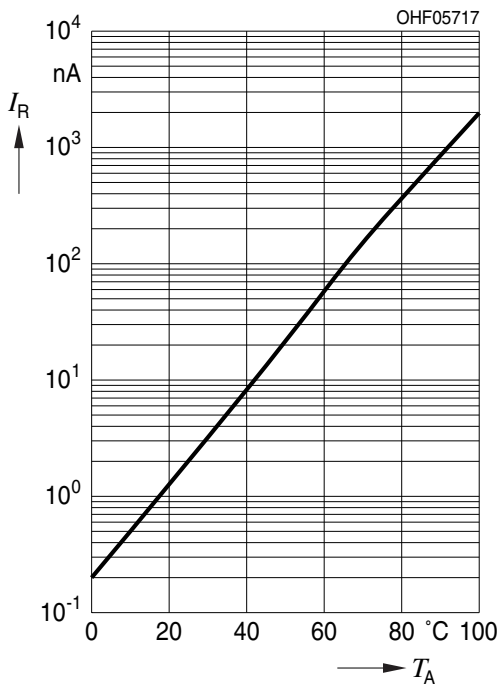

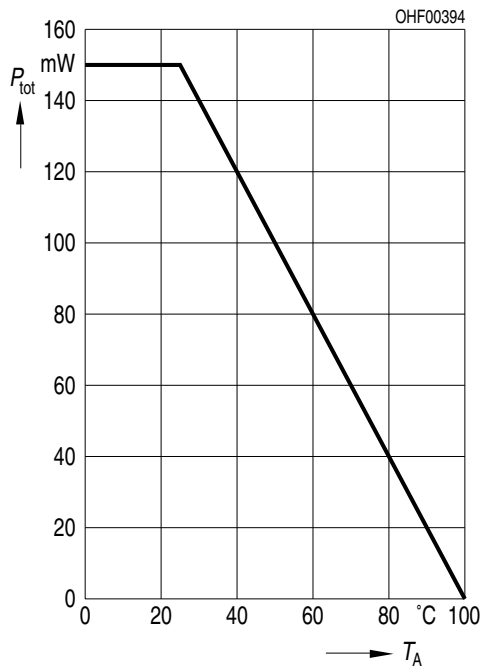

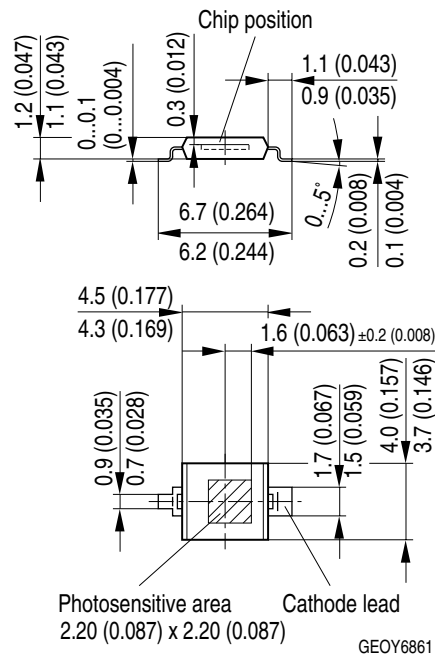

## Dimensional Drawing <sup>4)</sup>



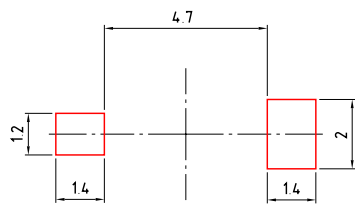

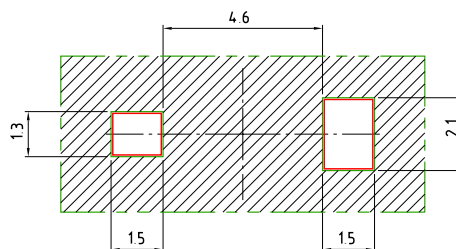

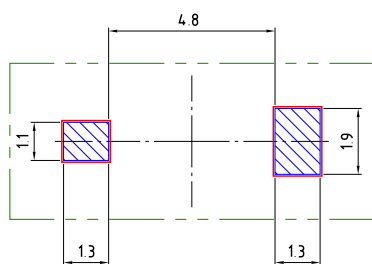
## Recommended Solder Pad 4)



□ footprint

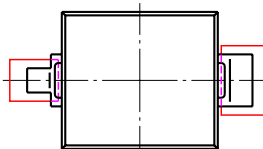

▨ solder stencil

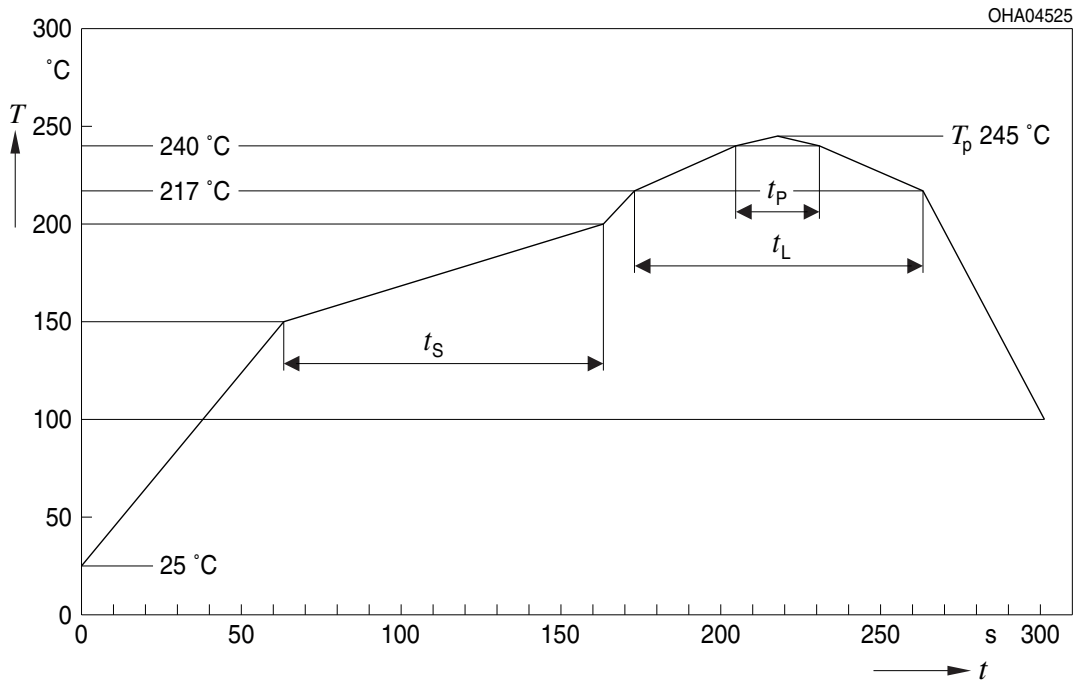
Component Location on Pad

## Notes
