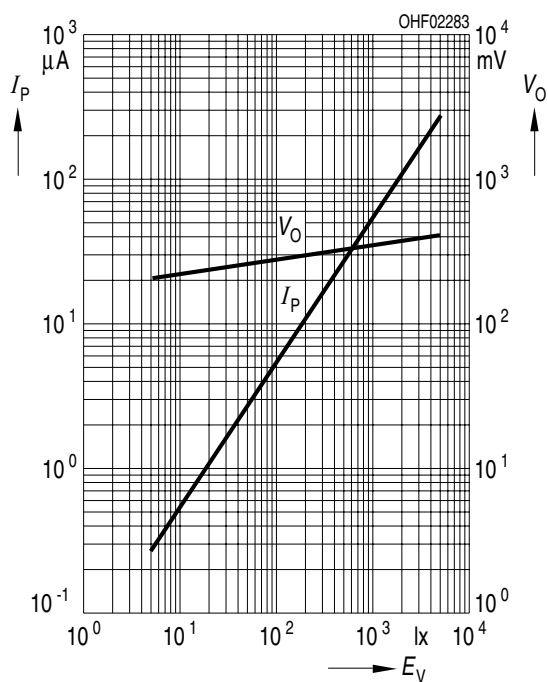

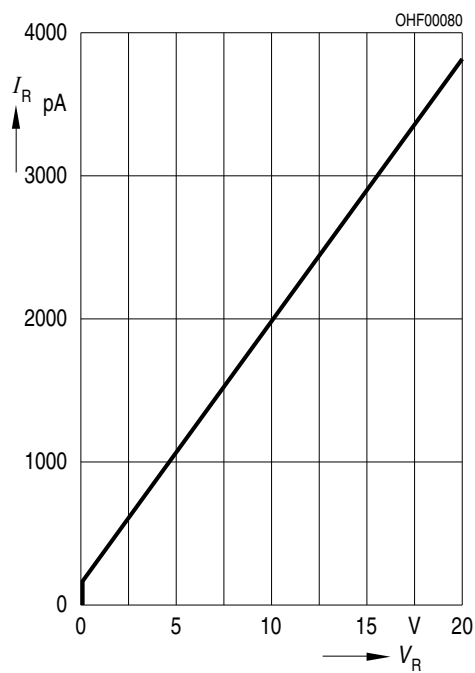

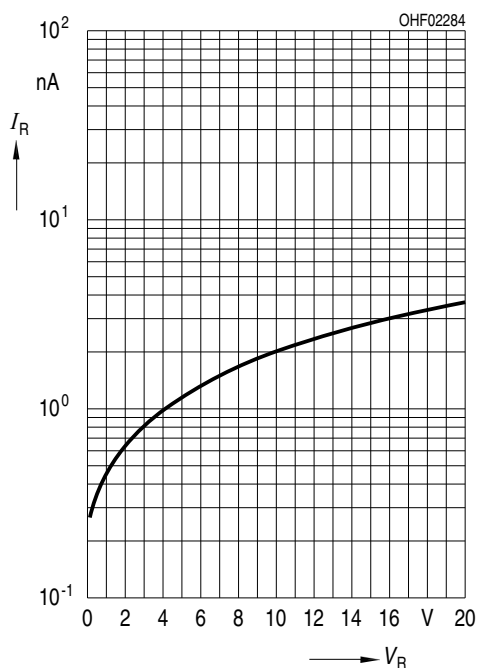

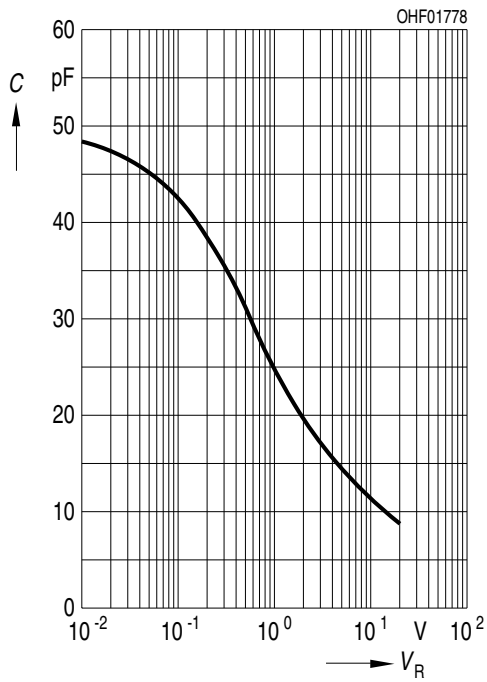

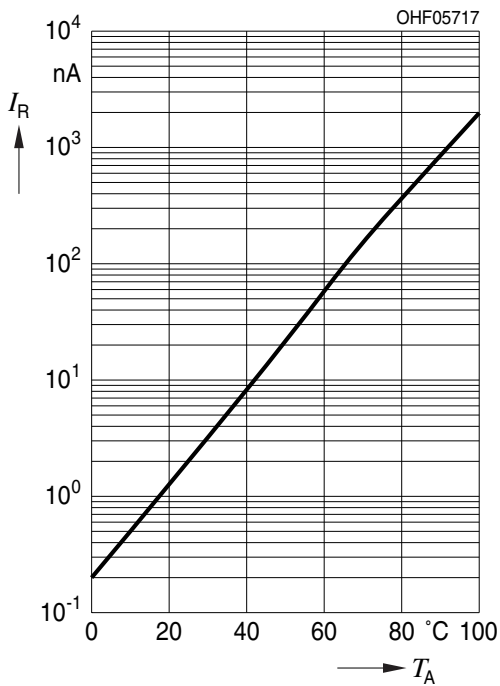

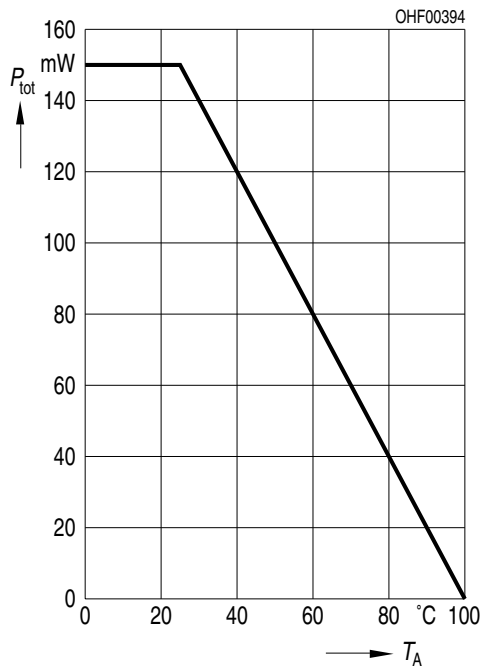

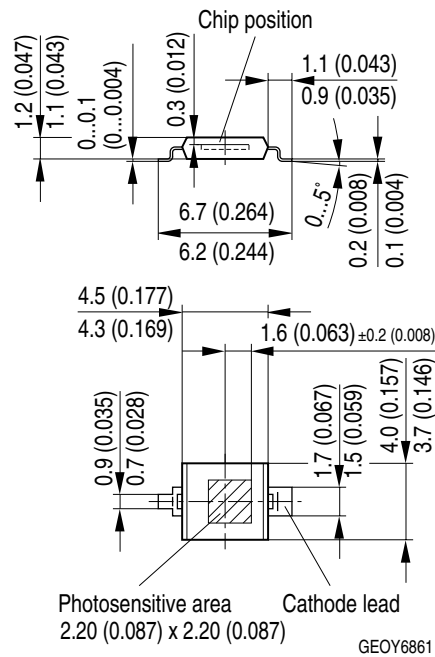

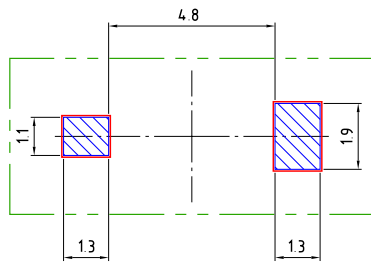
## Recommended Solder Pad 4)



foot print

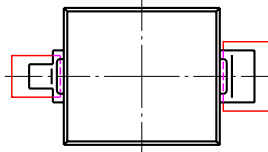

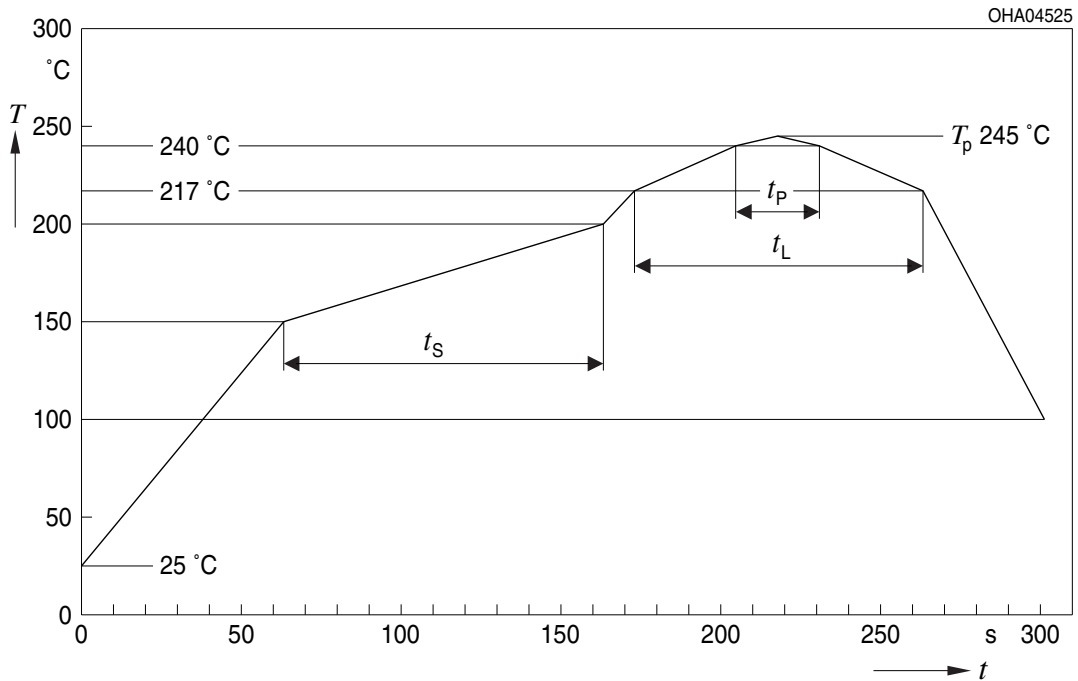
Component Location on Pad

## Notes
