


Relative Spectral Emission 6)








Permissible Pulse Handling Capability




Permissible Pulse Handling Capability

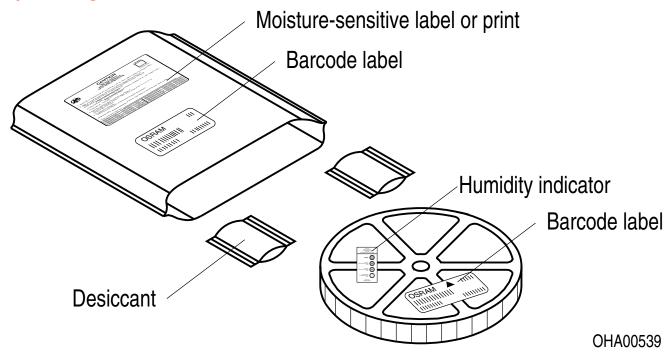
