





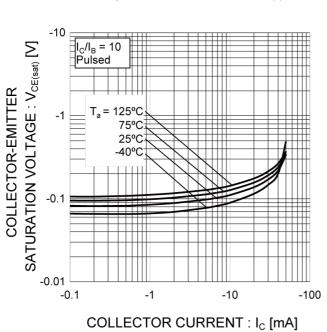
Fig.4 DC Current Gain vs. Collector Current (II)










### Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current (I)






# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.10 Safe Operating Area

# Fig.9 Collector Output Capacitance vs. Collector-Base Voltage


Fig.11 Safe Operating Area




