







Fig.2 Typical Output Characteristics( II )






















Fig.14 Maximum Safe Operating Aera




Fig.1-1 Switching Time Measurement Circuit




Fig.1-2 Switching Waveforms




Fig.2-1 Gate Charge Measurement Circuit




Fig.2-2 Gate Charge Waveform
