2. General


The TLP3317 is a photorelay in a 4-pin USOP that consists of a photo MOSFET optically coupled with an infrared LED. The TLP3317 is suitable for applications that require low output capacitance and high withstand voltage, such as LCD testers.

- (2) OFF-state output terminal voltage: 80 V (min)
- (3) Trigger LED current: 3 mA (max)
- (4) ON-state current: 120 mA (max)

- (7) Isolation voltage: 1000 Vrms (min)






Fig. 11.1 Switching Time Test Circuit and Waveform




Fig. 12.1.1 I_F - T_a




Fig. 12.1.2 I_{ON} - T_a




Fig. 12.1.3 I_F - V_F




Fig. 12.1.4 I_{ON} - V_{ON}




Fig. 12.1.5 R_{ON} - T_a




Fig. 12.1.6 I_{FT} - T_a






Fig. 12.1.7 toN, toFF - IF




Fig. 12.1.8 toN, toFF - Ta




Fig. 12.1.9 I_{OFF} - V_{OFF}





Fig. 12.1.10 $C_{OFF}/C_{OFF}(0 \text{ V}) - V_{OFF}$
