2. General

The TLP350H is a photocoupler in a DIP8 package that consists of a GaAlAs infrared light-emitting diode (LED) optically coupled to an integrated high-gain, high-speed photodetector IC chip. It provides guaranteed performance and specifications at temperatures up to 125 °C. The TLP350H has an internal Faraday shield that provides a guaranteed Common-mode transient immunity of ± 20 kV/µs. It has a totem-pole output that can both sink and source current.

The TLP350H is ideal for IGBT of small capacity to middle capacity and power MOSFET gate drive.




Fig. 13.1.1 IOPH Test Circuit





Fig. 13.1.3 V_{OH} Test Circuit








Fig. 13.1.2 I_{OPL} Test Circuit




Fig. 13.1.4 V_{OL} Test Circuit






Fig. 13.1.6 I_{CCL} Test Circuit









14. Soldering and Storage

14.1. Precautions for Soldering

The soldering temperature should be controlled as closely as possible to the conditions shown below, irrespective of whether a soldering iron or a reflow soldering method is used.


• When using soldering reflow.

The soldering temperature profile is based on the package surface temperature.

(See the figure shown below, which is based on the package surface temperature.)

Reflow soldering must be performed once or twice.

The mounting should be completed with the interval from the first to the last mountings being 2 weeks.







Fig. 14.1.1 An example of a temperature profile when Sn-Pb eutectic solder is used




14.2. Precautions for General Storage

- Avoid storage locations where devices may be exposed to moisture or direct sunlight.
- Follow the precautions printed on the packing label of the device for transportation and storage.
- Keep the storage location temperature and humidity within a range of 5 °C to 35 °C and 45 % to 75 %, respectively.
- Do not store the products in locations with poisonous gases (especially corrosive gases) or in dusty conditions.
- Store the products in locations with minimal temperature fluctuations. Rapid temperature changes during storage can cause condensation, resulting in lead oxidation or corrosion, which will deteriorate the solderability of the leads.
- \cdot $\,$ When restoring devices after removal from their packing, use anti-static containers.
- Do not allow loads to be applied directly to devices while they are in storage.
- If devices have been stored for more than two years under normal storage conditions, it is recommended that you check the leads for ease of soldering prior to use.







Fig. 17.3 Marking on Packing for EN60747
