



Then, for normal switching operation,  $V_{GS(ON)}$  must be higher than  $V_{th}$ , and  $V_{GS(OFF)}$  must be lower than  $V_{th}$ . This relationship can be expressed as:  $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$ . Take this into consideration when using the device.




Fig. 6.3.1 Test Circuit of Switching Time





Fig. 7.1 Marking





Fig. 8.11 Dynamic Input Characteristics


