



Pin Condition (top view)






Usage Considerations


Let Vth be the voltage applied between gate and source that causes the drain current (ID) to below (1 mA for the SSM3K35CT). Then, for normal switching operation, $V_{GS(on)}$ must be higher than V_{th} , and $V_{GS(off)}$ must be lower than $V_{th.}$ This relationship can be expressed as: $V_{GS(off)} < V_{th} < V_{GS(on).}$


