

- Note 1: If a reverse bias is applied between gate and source, this device enters V_{(BR)DSX} mode. Note that the drain-source breakdown voltage is lowered in this mode.
- Note 2: Let V_{th} be the voltage applied between gate and source that causes the drain current (I_D) to below (-1 mA for this device). Then, for normal switching operation, $V_{GS(ON)}$ must be higher than V_{th} , and $V_{GS(OFF)}$ must be lower than V_{th} . This relationship can be expressed as: $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$.






Fig. 5.3.1 Switching Time Test Circuit








Fig. 8.1 $I_D - V_{DS}$




Fig. 8.2 I_D - V_{GS}




Fig. 8.3 R_{DS(ON)} - V_{GS}




Fig. 8.4 R_{DS(ON)} - V_{GS}




Fig. 8.5 R_{DS(ON)} - I_D





Fig. 8.6 R_{DS(ON)} - T_a





Fig. 8.8 |Y_{fs}| - I_D







Fig. 8.9 C - V_{DS}

Fig. 8.10 Dynamic Input Characteristics






Fig. 8.11 t - I_D




Fig. 8.13 rth - tw




Fig. 8.14 PD - Ta





Fig. 8.15 Safe Operating Area
