






Fig. 11.1 Switching Time Test Circuit and Waveform











Fig. 12.1.4 I_{ON} - V_{ON}






Fig. 12.1.6 I_{FT} - T_a






Fig. 12.1.7 t_{ON} , t_{OFF} - I_F




Fig. 12.1.8 t_{ON} , t_{OFF} - T_a




Fig. 12.1.9 I_{OFF} - V_{OFF}





Fig. 12.1.10 C_{OFF}/C_{OFF}(0 V) - V_{OFF}
