




Fig. 13.5 Q1 h_{FE}-I_C




Fig. 13.7 Q1 V_{CE(sat)}-I_C

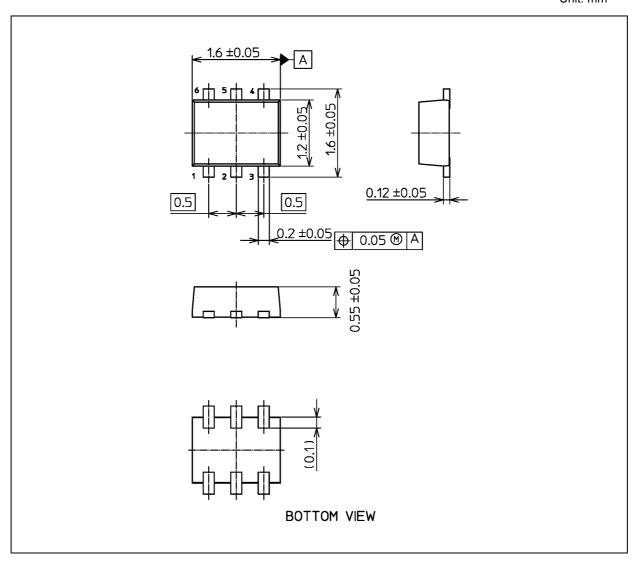
Fig. 13.8 Q2 V_{CE(sat)}-I_C
