





Fig. 5.1 Device Mounted on a Glass-Epoxy Board (a)




Fig. 6.2.1 Switching Time Test Circuit







Fig. 8.1 I_D - V_{DS}

Gate-source voltage V_{GS} (V) Fig. 8.3 I_D - V_{GS}




Fig. 8.5 R_{DS(ON)} - I_D




Fig. 8.2 I_D - V_{DS}




Fig. 8.4 V_{DS} - V_{GS}




Fig. 8.6 I_{DR} - V_{DS}






Fig. 8.7 V_{(BR)DSS} - T_a




Fig. 8.9 R_{DS(ON)} - T_a




Fig. 8.11 Capacitance - V_{DS}




Fig. 8.8 V_{th} - T_a




Fig. 8.10 Dynamic Input/Output Characteristics




Fig. 8.12 Qoss - VDS




Fig. 8.13 r_{th} - t_w (Bottom drain) (Guaranteed Maximum)




Fig. 8.14 r_{th} - t_w (Top source) (Guaranteed Maximum)




Fig. 8.15 P_D - T_a (Guaranteed Maximum)




Fig. 8.16 P_D - T_c (Bottom drain) (Guaranteed Maximum)






Fig. 8.17 Safe Operating Area (Guaranteed Maximum)


