Precaution

Vth can be expressed as the voltage between gate and source when the low operating current value is ID = -1 mA for this product. For normal switching operation, V_{GS} (on) requires a higher voltage than V_{th} and V_{GS} (off) requires a lower voltage than Vth.

(The relationship can be established as follows: V_{GS} (off) < V_{th} < V_{GS} (on).)


