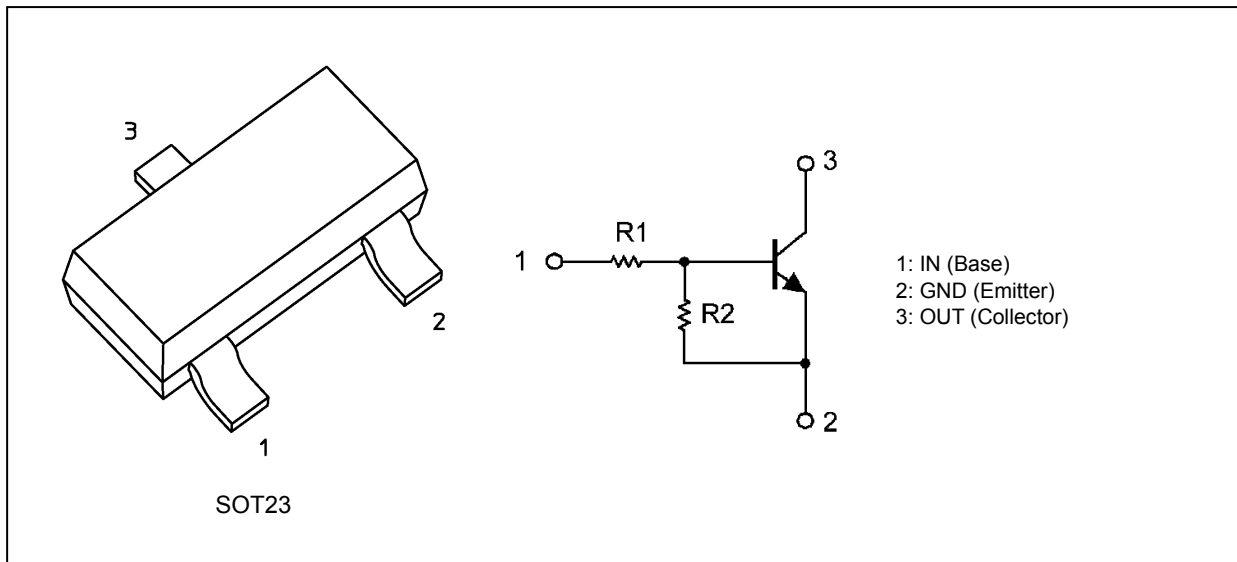

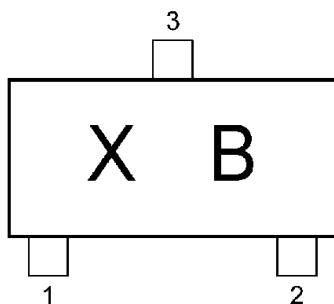

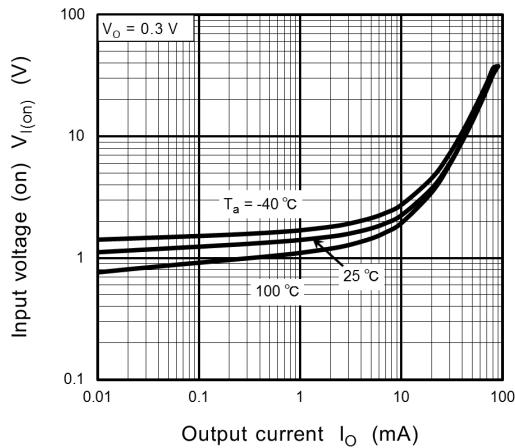


Fig. 7.1 $V_{I(on)} - I_O$

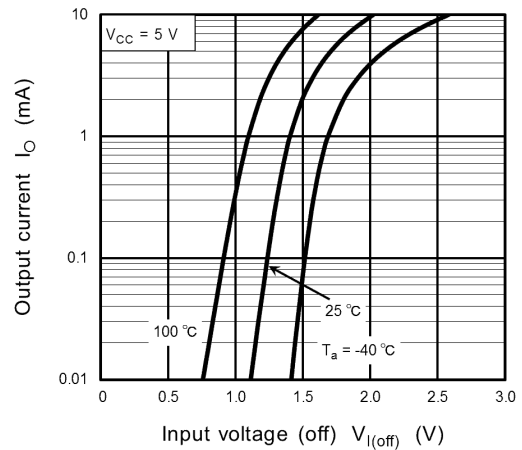


Fig. 7.2 $I_O - V_{I(off)}$

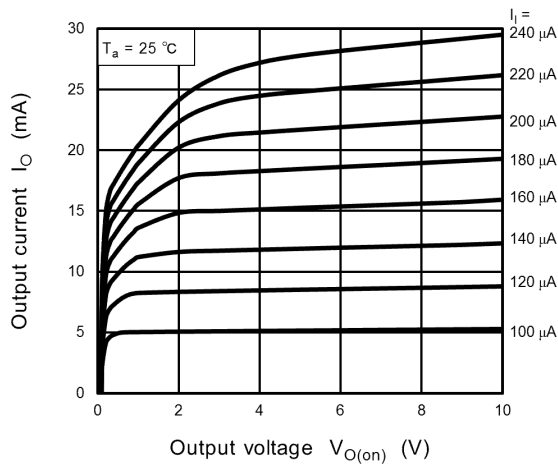


Fig. 7.3 $I_O - V_O$

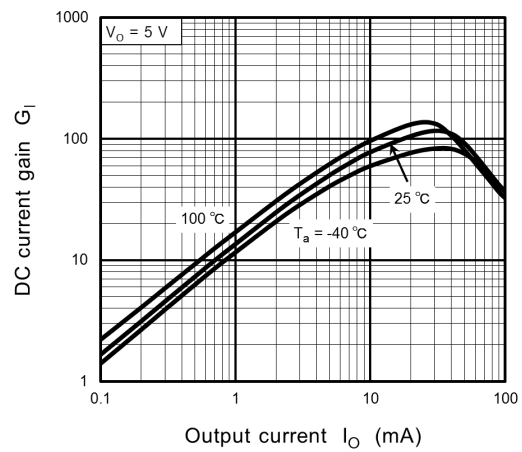


Fig. 7.4 $G_I - I_O$

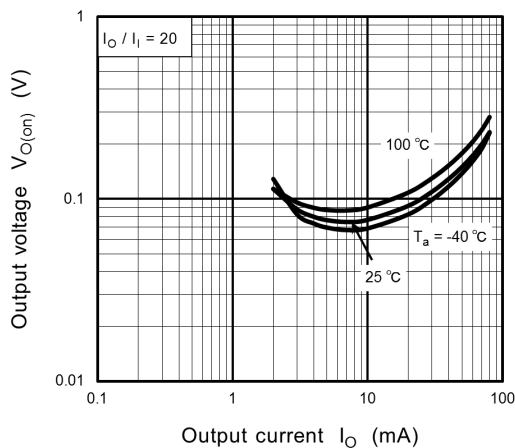
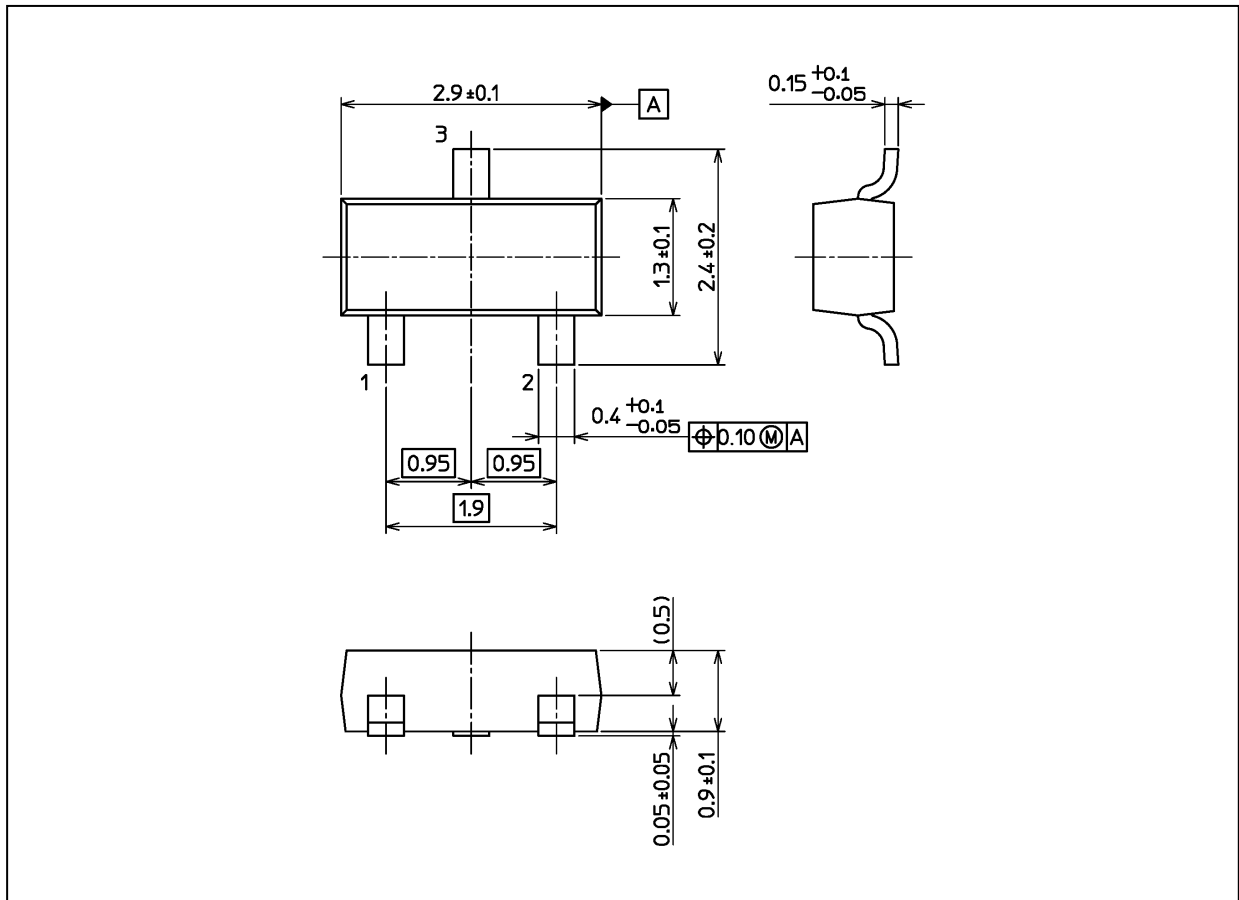


Fig. 7.5 $V_{O(on)} - I_O$
