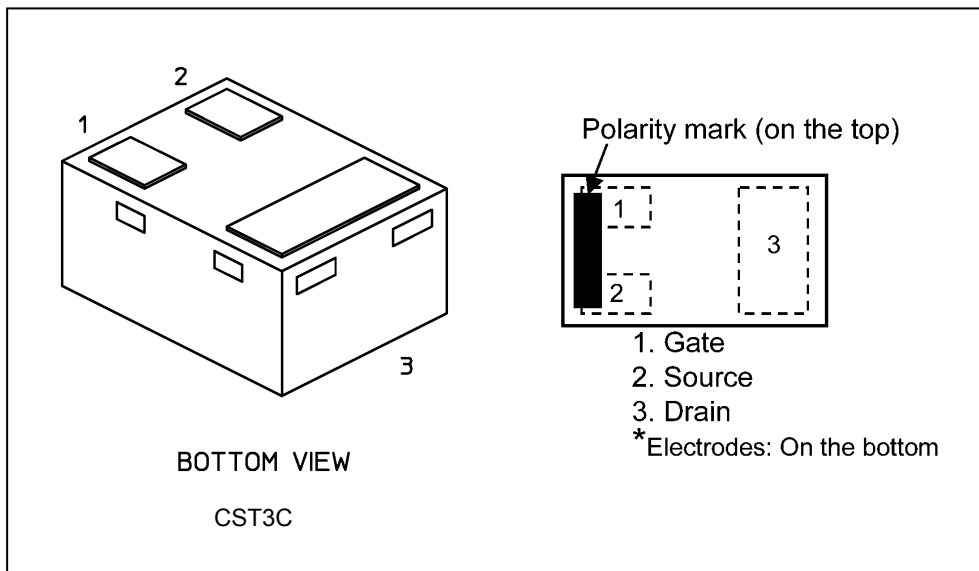

Note 1: If a reverse bias is applied between gate and source, this device enters  $V_{(BR)DSX}$  mode. Note that the drain-source breakdown voltage is lowered in this mode.

Note 2: Let  $V_{th}$  be the voltage applied between gate and source that causes the drain current ( $I_D$ ) to below (-1 mA for this device). Then, for normal switching operation,  $V_{GS(ON)}$  must be higher than  $V_{th}$ , and  $V_{GS(OFF)}$  must be lower than  $V_{th}$ . This relationship can be expressed as:  $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$ .

Take this into consideration when using the device.

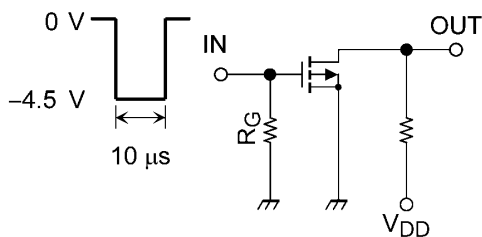


Fig. 5.3.1 Switching Time Test Circuit

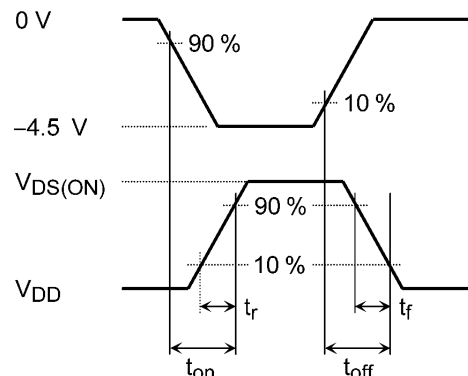


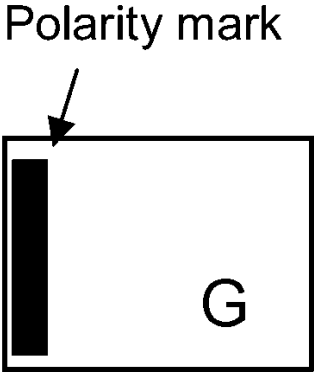
Fig. 5.3.2 Input Waveform/Output Waveform

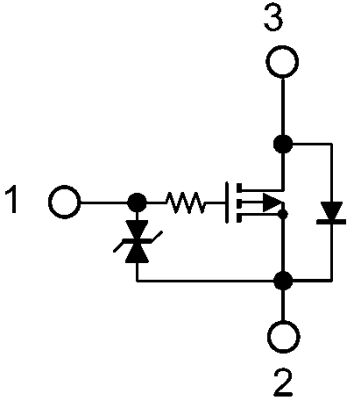

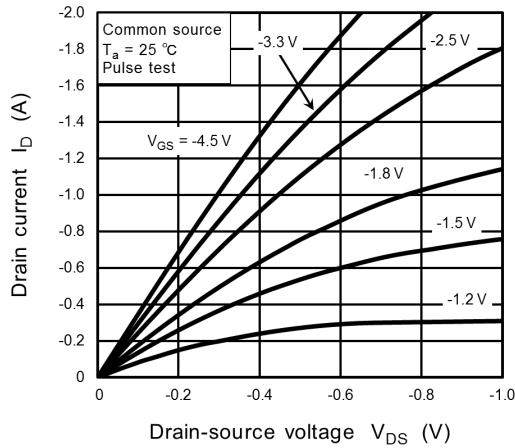

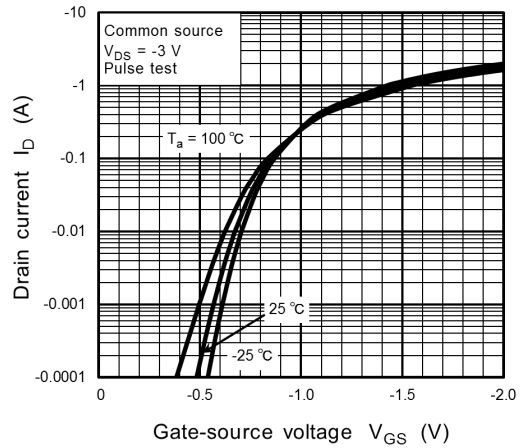

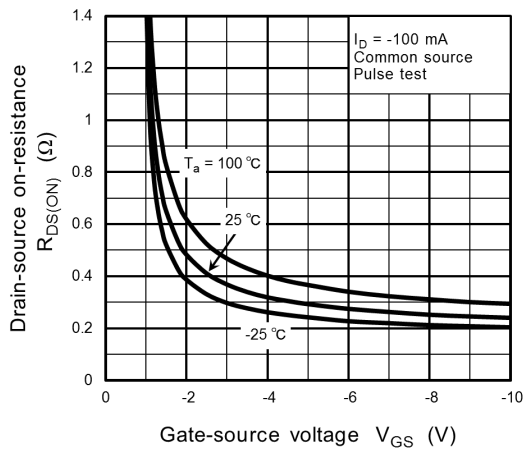

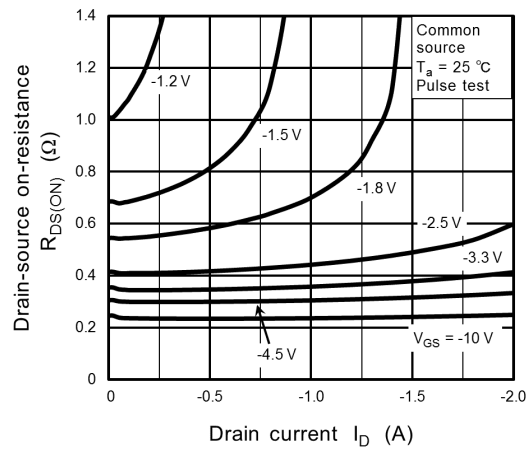
**Fig. 8.1  $I_D - V_{DS}$**



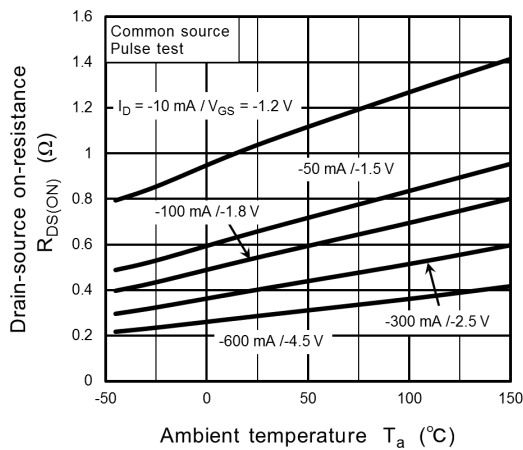
**Fig. 8.2  $I_D - V_{GS}$**



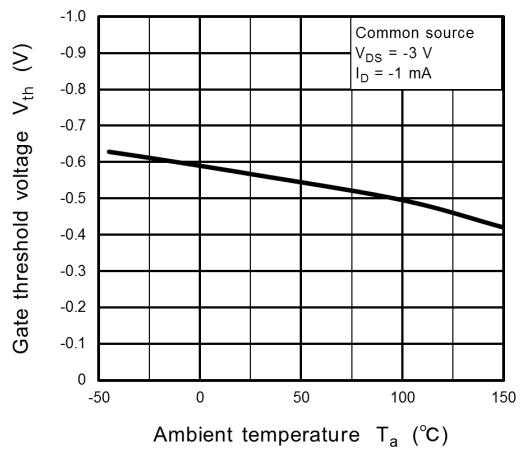
**Fig. 8.3  $R_{DS(ON)} - V_{GS}$**



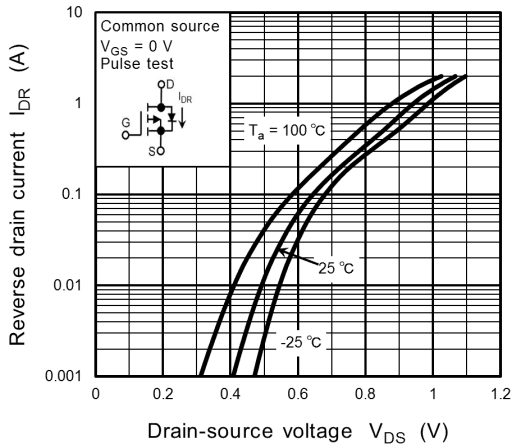
**Fig. 8.4  $R_{DS(ON)} - I_D$**



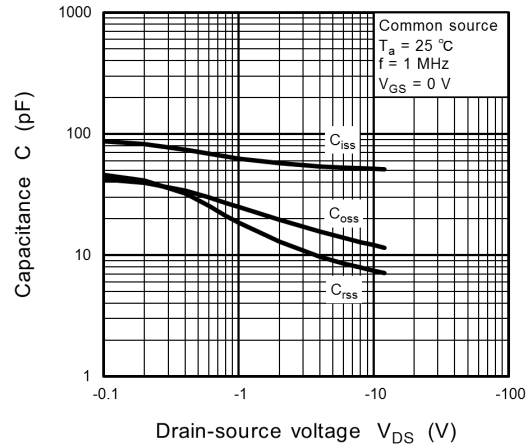
**Fig. 8.5  $R_{DS(ON)} - T_a$**



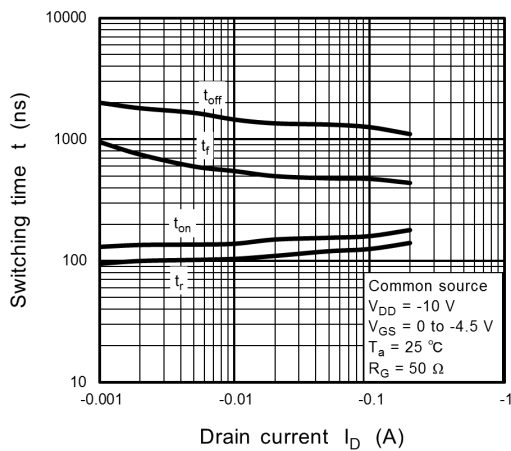
**Fig. 8.6  $V_{th} - T_a$**



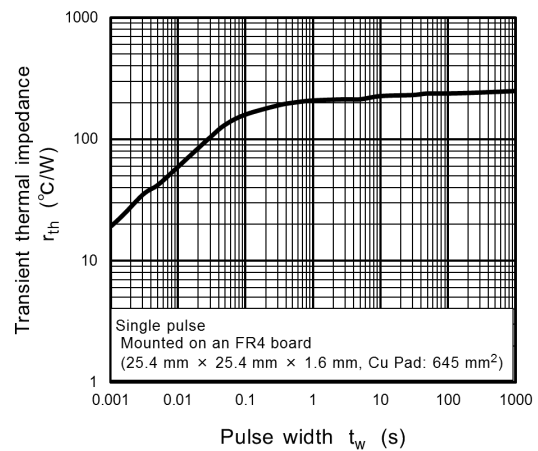
**Fig. 8.7**  $I_{DR} - V_{DS}$



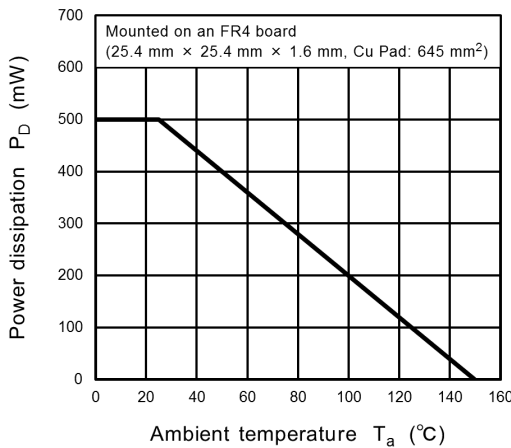
**Fig. 8.8**  $C - V_{DS}$

**Fig. 8.10**  $r_{th} - t_w$

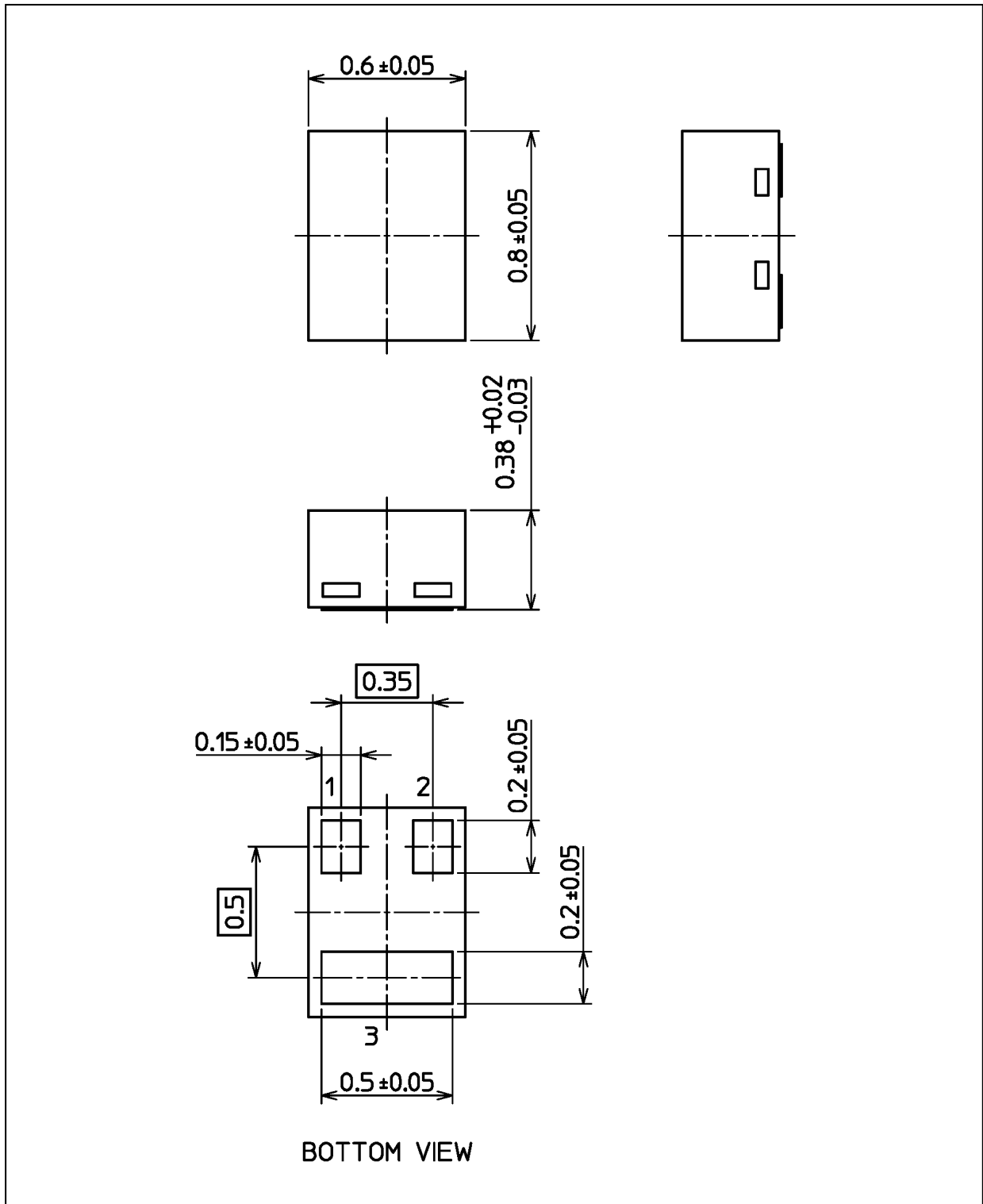


**Fig. 8.11**  $P_D - T_a$
