


Fig. 6.2.1 Switching Time Test Circuit







Fig. 8.1 I_D - V_{DS}



Gate-source voltage V_{GS} (V) Fig. 8.3 V_{DS} - V_{GS}




Fig. 8.5 V_{DS} - V_{GS}




Fig. 8.2 I_D - V_{DS}




Fig. 8.4 V_{DS} - V_{GS}




Fig. 8.6 V_{DS} - V_{GS}




Fig. 8.7 ID - VGS




Fig. 8.9 R_{DS(ON)} - T_a




Fig. 8.11 V_{(BR)DSS} - T_a




Fig. 8.8 R_{DS(ON)} - I_D




Fig. 8.10 I_{DR} - V_{DS}




Fig. 8.12 V_{th} - T_a






Fig. 8.13 Capacitance - V_{DS}




Fig. 8.15 EAS - Tch(Guaranteed Maximum)




Fig. 8.14 Dynamic Input/Output Characteristics




Fig. 8.16 Test Circuit/Waveform






Fig. 8.17 $z_{th(ch-c)}$ - t_w (Guaranteed Maximum)




Fig. 8.18 P_D - T_a (Guaranteed Maximum)




Fig. 8.19 P_D - T_c (Guaranteed Maximum)




Fig. 8.20 Safe Operating Area (Guaranteed Maximum)


