




Avalanche Current vs. Time







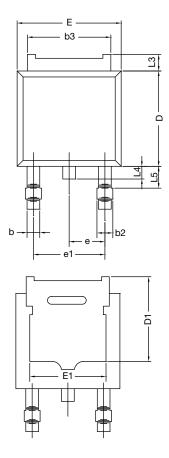
#### **THERMAL RATINGS**


