



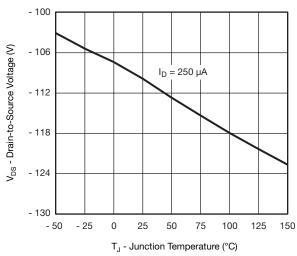
Source-Drain Diode Forward Voltage




Threshold Voltage




 V_{DS} - Drain-to-Source Voltage (V) Capacitance

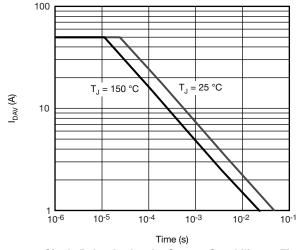








Single Pulse Avalanche Current Capability vs. Time




