



Fig. 1 - Maximum Forward Current Derating Curve




Fig. 3 - Maximum Non-repetitive Peak Forward Surge Current





Fig. 4 - Maximum Non-repetitive Reverse Avalanche Power Dissipation

### **PACKAGE OUTLINE DIMENSIONS** in inches (millimeters) DO-204AC (DO-15)






Fig. 5 - Typical Reverse Leakage Characteristics
