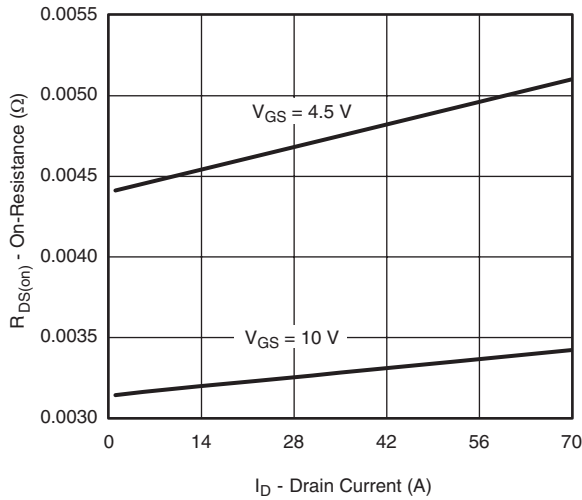

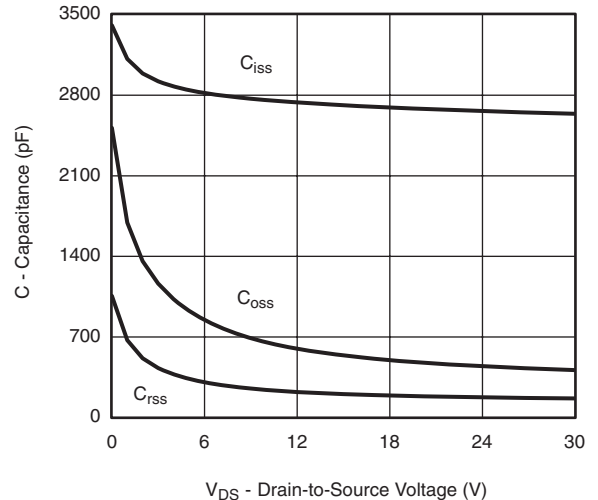

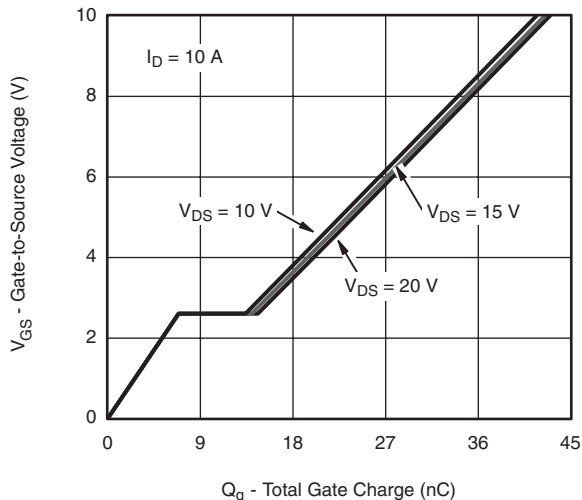

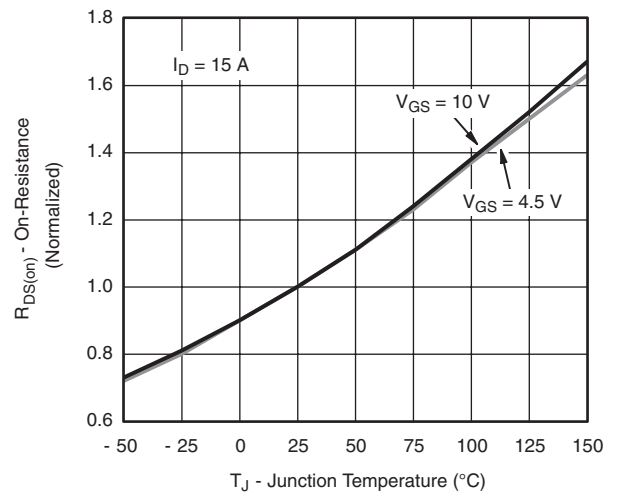
On-Resistance vs. Drain Current and Gate Voltage

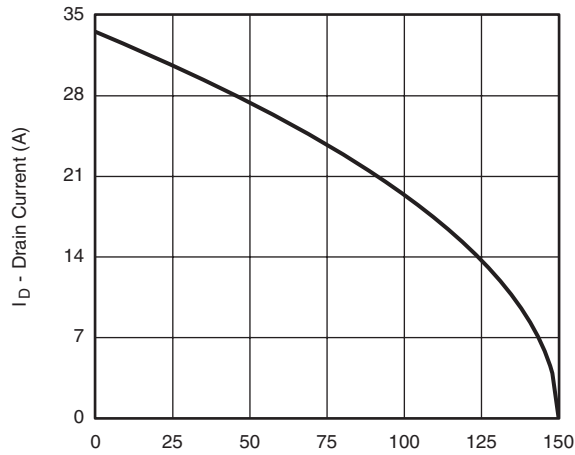

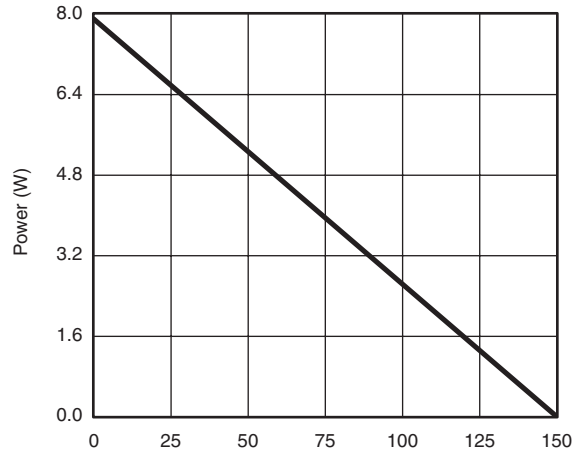
Safe Operating Area, Junction-to-Ambient



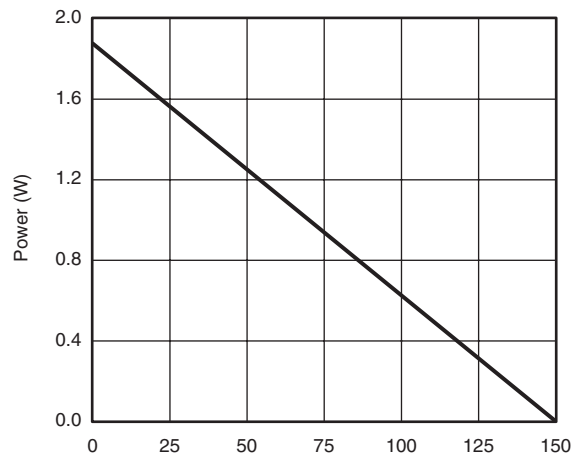

Power Derating, Junction-to-Foot

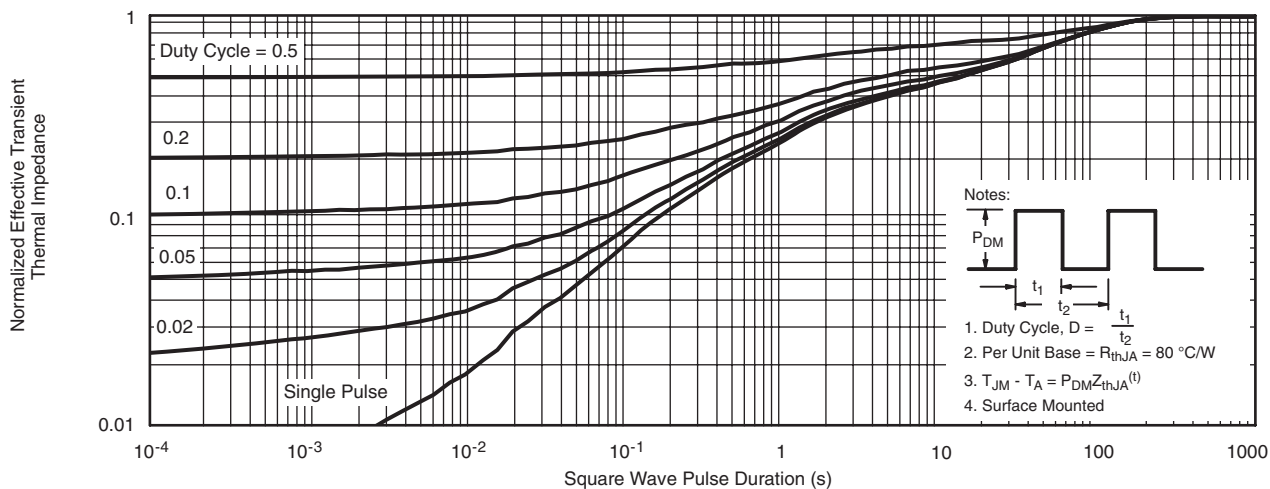


T_A - Ambient Temperature (°C)

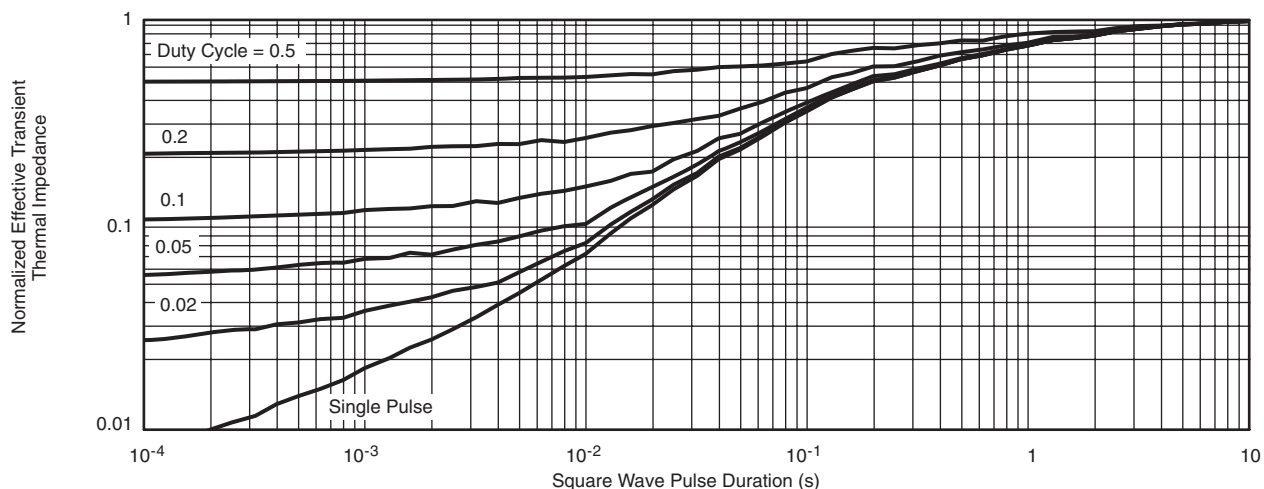
