


Fig. 1 - Peak Pulse Power Rating Curve






Fig. 2 - Pulse Power or Current vs. Initial Junction Temperature








Fig. 4 - Typical Junction Capacitance Uni-Directional




Fig. 5 - Power Derating Curve




Fig. 6 - Maximum Non-Repetitive Forward Surge Current





Fig. 7 - Typical Transient Thermal Impedance

- This P6KE TVS series is a low cost commercial product for use in applications where large voltage transients can permanently damage voltage-sensitive components.
- The P6KE series device types are designed in a small package size where power and space is a consideration. They are characterized by their high surge capability, extremely fast response time, and low impedance, (Ron). Because of the unpredictable nature of transients, and the variation of the impedance with respect to these transients, impedance, per se, is not specified as a parametric value. However, a minimum voltage at low current conditions (BV) and a maximum clamping voltage (V_c) at a maximum peak pulse current is specified.
