






THERMAL RATINGS ($T_A = 25 \text{ °C}$, unless otherwise noted)

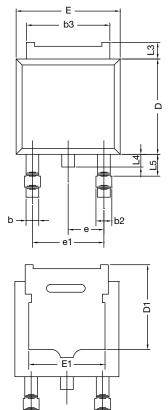

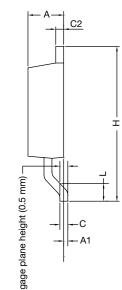
