














Gate Current vs. Gate-Source Voltage




On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-Source Voltage



Source-Drain Diode Forward Voltage




Threshold Voltage




Drain-Source Breakdown vs. Junction Temperature


Safe Operating Area
