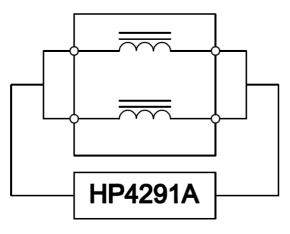
Recommended PC Board Pattern

TAI-TECH 5.Schematic Diagram

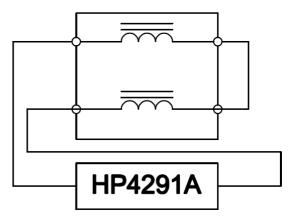

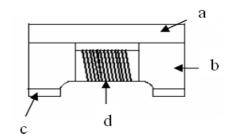

9. Soldering and Mounting

9-1. Soldering

Mildly activated rosin fluxes are preferred. TAI-TECH terminations are suitable for all wave and re-flow soldering systems. If hand soldering cannot be avoided, the preferred technique is the utilization of hot air soldering tools.

9-1.1 Solder re-flow:

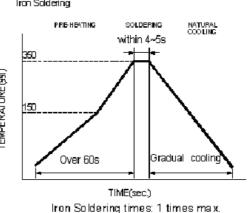

9-1.2 Soldering Iron(Figure 2):

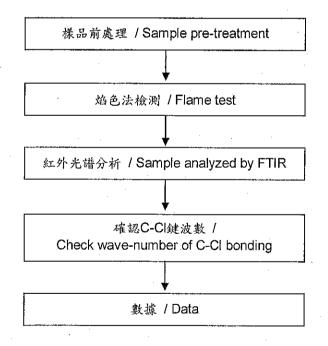

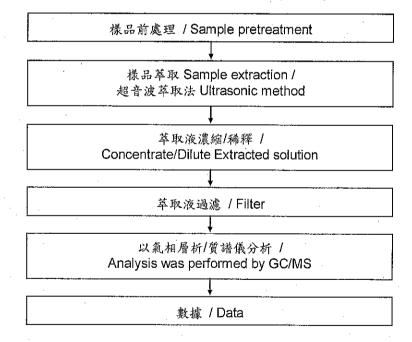

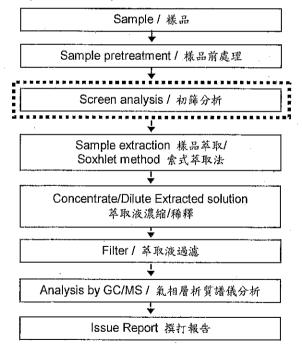
