



Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




Fig. 4. Forward current as a function of forward voltage; typical values




Fig. 5. Reverse current as a function of reverse voltage; typical values






Fig. 6. Diode capacitance as a function of reverse voltage; typical values


Average forward power dissipation as a function of average forward current; typical values

FR4 PCB, standard footprint T_i = 150 °C








