#### 6-2. Soldering

Mildly activated rosin fluxes are preferred. TAI-TECH terminations are suitable for re-flow soldering systems. If hand soldering cannot be avoided, the preferred technique is the utilization of hot air soldering tools.

#### 6-2.1 Soldering Reflow:




- Preheat circuit and products to  $150\,^\circ\!\mathrm{C}$

- · Never contact the ceramic with the iron tip






