### 6-2. Soldering

Mildly activated rosin fluxes are preferred. TAI-TECH terminations are suitable for re-flow soldering systems. If hand soldering cannot be avoided, the preferred technique is the utilization of hot air soldering tools.

#### 6-2.2 Soldering Iron:





Fig.2 Iron soldering temperature profiles

Products attachment with a soldering iron is discouraged due to the inherent process control limitations. In the event that a soldering iron must be employed the following precautions are recommended. (Figure 2.)

- $\bullet$  Preheat circuit and products to 150  $\!\!\!\!\!^{\circ}_{\circ}$
- Never contact the ceramic with the iron tip1.0mm tip diameter (max)
- ${\boldsymbol \cdot}$  Use a 20 watt soldering iron with tip diameter of 1.0mm
- Limit soldering time to 4~5sec.

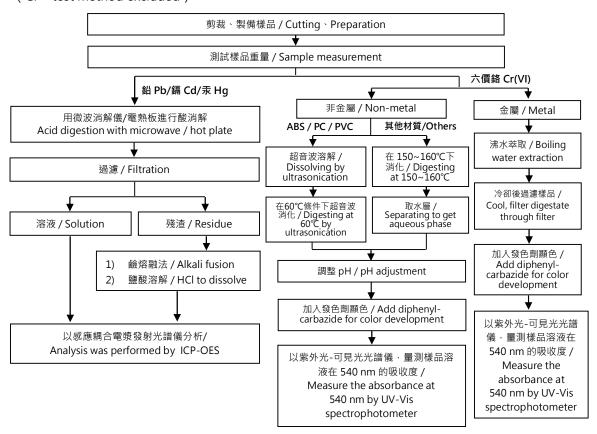

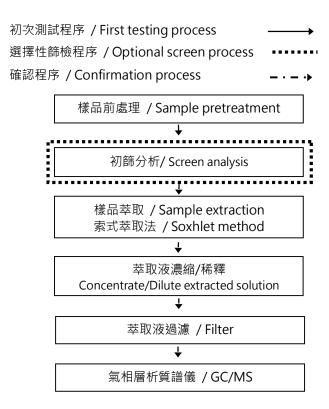

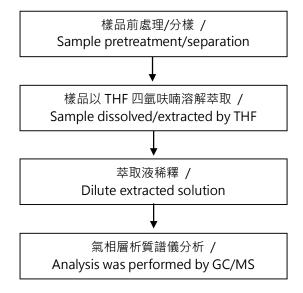

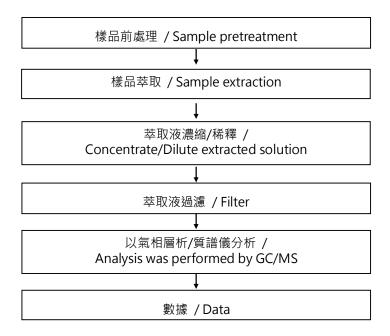

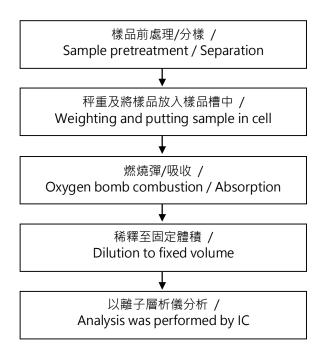

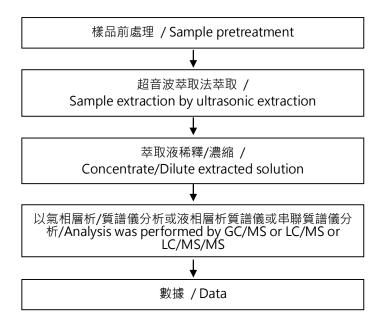

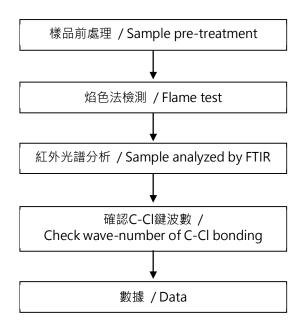

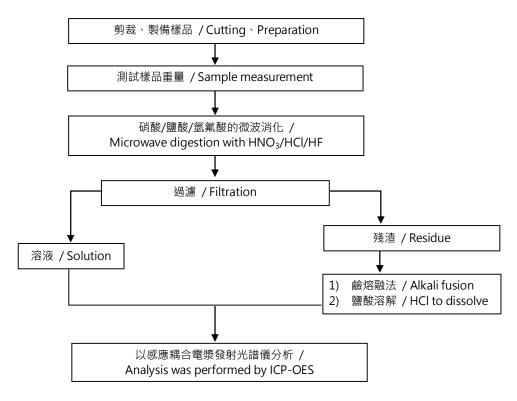
